

# PRE-ARRIVAL CHECKLIST

## 1 Accomplish the Health Declaration Card (HDC).

Go to <http://aklan.gov.ph> or <https://bit.ly/2QzbUKZ>.

Click Online Health Declaration. Choose Boracay in the "Where To" page.

Upon submission, a confirmation with instructions will be displayed.

## 2 Keep a copy of your Health Declaration Card.

Save a copy in your smartphone or print a hard copy.

## 3 "Test Before Travel" policy applies.

Take an RT - PCR test not earlier than 72 hours prior to traveling to Boracay.

*A Philippine Red Cross administered RT-PCR Saliva Test is permitted for tourists to Boracay. Visit [book.redcross.org.ph](http://book.redcross.org.ph).*

*After undergoing the test, please quarantine at home to avoid possible exposure. Only those with a negative test result will be allowed to travel. Falsified, tampered or fraudulent test results are punishable by law.*

## 4 Send an email with your complete documents/requirements to [touristboracay@gmail.com](mailto:touristboracay@gmail.com).

### Requirements:

- Negative RT-PCR test result.
- Health Declaration Card.
- Hotel and airline booking confirmation.
- Proof of identification.
- S-Pass Travel Coordination Permit (TCP).
- Screenshot of health declaration card confirmation page.

*Multiple tourist documents can be sent in one email. Just include a listing of the names of the tourists.*

## 5 Get an S-Pass Travel Coordination Permit (TCP).

Go to <https://s-pass.ph/>.

Create an account.

After creating an account, click "Are You Traveling" and complete necessary information. Make sure to select "Aklan – Malay" as your destination. Scroll down to the bottom of the page to see all steps required.

Wait for your Travel Coordination Permit (TCP).

Save your TCP in your smartphone.

## 6 Wait for the response.

**For successful** – a copy of HDC with Tourist QR Code will be sent back. Present these to authorities in the borders for scanning.

**For unsuccessful** – resubmission of requirements or a clarification may be required.

## 7 Bring copies of all required documents.

- Completed Health Declaration Card with Tourist QR Code.
- Negative RT – PCR test result.
- Hotel and airline booking confirmation.
- Identification card/s.
- S-Pass Travel Coordination Permit (TCP).
